Minimise contact between individuals and maintain social distancing wherever possible Schools must do everything possible to minimise contacts and mixing while delivering a broad and balanced curriculum.	Keep year groups separate (in 'bubbles') and maintaining distance between individuals. It is acceptable for younger children (Nursery, EYFS and YI) not to distance within their group. Signage around the school will promote social distancing.  Use of consistent groups to reduce the risk of transmission by limiting the number of pupils and staff in contact with each other to only those within the group.  The outside area is zoned to minimise contact between year groups/ classes (Nursery).  For intervention, small group focus teaching the following will be followed:  Staff wash hands before and after working with pupils  Staff will work only with children in the same bubble  A space is identified for the intervention to take place and set up with separate desks placed a suitable distance apart  All equipment needed for the child is set up in the space before the start of the session  The intervention is provided at a distance and the adult may wear a mask or visor	M	L
	Teachers and other staff who need to operate across different classes and year groups should try and keep their distance from pupils and other staff as much as they can, ideally 2 metres from other adults and can wear a mask if they choose to.		

Working within a bubble and across the school	Reduce the amount of time there is face to face to contact to lower the risk of transmission, however if the curriculum demands the needs for collaborative work and the room is well ventilated this is possible.	М	L

	For pupils who have complex needs or who need close contact care then the adult working with that child can request an individual risk assessment		
	For individual and very frequently used equipment, such as pencils and pens, staff and pupils will have their own items that are not shared. Each pupil (Y2-6) will have their own pencil case.	М	L
	Where possible meetings will be conducted via video conferencing (including Learning Reviews 22.11.21).	н	L
	Where this is not possible meetings will be conducted outside, or in a large room large enough to maintain social distance.		
	Use of the toilets to be actively managed to prevent overcrowding (each year group using their allocated toilets, including at lunchtime).		
	Staggered break times and lunch times (and time for cleaning surfaces in the dining hall between groups)		
	Use of outside areas to be timetabled and zoned.		
	UKS2 – Y4, Y5, Y6 – mixed on the playground over break and lunch time		
	The Behaviour Policy and the Home/School Covid Agreement will support behaviour expectations in school.		
	Children will be encouraged to learn and practise good hygiene and always sanitise their hands when they return to the classroom after a break and before lunch.		
	All staff can access the facilities in the staffroom but must be mindful of how many people are already in there. Use of staff rooms should be minimised, although staff must still have a break of a reasonable length during the day.		
	All adults to wear face masks in communal areas.		

	Resources that are shared between classes or bubbles, such as sports and science equipment will be cleaned frequently and children will be asked to wash their hands before and after using the equipment.		
	Use of planned routes and movement times limits contact between groups in school.	н	L

Measures for arriving at and leaving school	Staggered starts and finish times to keep groups apart as they arrive and leave school. This will not reduce the amount of overall teaching time.	н	L
	Remind parents and carers that gathering at the school gates is not advisable		
	Encourage walking and or cycling to school to avoid use of public transport.	М	L
	Pupils wearing face coverings/ mask when arriving to school will wash hands and will dispose of the mask or store in plastic bag if not a disposable mask.		
Visitors to the school site	Supply teachers, peripatetic teachers and/or volunteers will ensure they minimise contact and maintain as much distance as possible from other staff.	н	L
	Protective screens in the office, one parent at a time can enter the office area if there is no alternative. Office staff to speak to Parents, contractors, parents at the school gate whenever possible.		
	All visitors must wear a face mask when they are inside the school building.	_	
	Specialists, therapists, clinicians and other support staff for pupils with SEND will provide interventions as usual but will minimise contact and maintain as much distance as is possible. These expectations will be communicated upon arrival at school.		
	Where visits, from contractors, can happen outside of school hours, they should.		
	Site guidance on physical distancing and hygiene is explained to visitors on or before arrival. They will be reminded to sanitise their hands and where possible wear a mask.

	A record will be kept of all visitors. Volunteers can visit if they are not going into other schools, are known to us and follow all our guidelines.		
	Parents/carers informed that they are not allowed on site without pre-arranged permission.		
	That masks must be worn inside the school building.		
	That no-more than 30 Parents can be in attendance at any one event in the Upper or Lower Hall.		
Staff, parents and carers who are anxious about returning	Those living in households where someone is clinically vulnerable, or those concerned about the comparatively increased risk from coronavirus, including those from Black, Asian and Minority Ethnic (BAME) backgrounds or who have certain conditions such as obesity and diabetes should discuss their concerns with the school and if necessary, an individual risk assessment should be considered. 	Staff who are clinically extremely vulnerable will have been identifies via letter either from their GP or NHS. Staff in this category (CEV) should talk to the Head Teacher about how they will be supported, including to work from home where possible.		
	All other staff should continue to attend work, including those living in a household with someone who is clinically extremely vulnerable.		
Pupils/Families with complex health needs	Children originally identified as clinically extremely vulnerable may no longer need to follow shielding advice. Parents will be advised to speak to their child's GP or specialist clinician. If doctors confirm they are still extremely clinically vulnerable and are advised not to attend child care this will be recorded as authorised absence.	н	L
	Children who live with someone who is clinically extremely vulnerable, but who are not clinically extremely vulnerable themselves, should still attend school. When this is not happening school will contact the Southwark back to school team for advice.		
Mental health and wellbeing affected through isolation or anxiety about coronavirus	Have regular keeping in touch meetings and discussions with staff and pupils.  Communicate to staff and pupils about how to raise concerns or who to go to so they can talk things through.  Involve staff in completing risk assessments so they can help identify potential problems and identify solutions. If a child is in school with a cough or cold but is not unwell	Staff may wish to mention to the Parent/carer that their child has been coughing or sneezing and suggest they contact their GP or 111 for advice.		

NB: Many children have coughs and colds at this time of year and if Parents chose to send them in because they are fine then school must respect this.	
If members of staff are worried that a child might be infectious and shouldn't be in school (even though the Parent/Carer insists they are fine) then contact a member of the Senior Leadership and they will have the conversation with the Parent/carer. Parents regularly reminded not to send their children into school if they are unwell.

	Staff members and parents/carers understand that they will need to be ready and willing to:		
	<ul> <li>book a test if they are displaying symptoms or a member of their household has tested positive.</li> </ul>		
	All children can be tested, including children under 5, but children aged 11 and under will need to be helped by their parents/carers if using a home testing kit		
	Tests can be booked online through the NHS <u>testing and tracing for coronavirus website</u> , or ordered by telephone via NHS 119.		
	Essential workers, which includes anyone involved in education or childcare, have priority access to testing.		
	Schools will be provided with a small number of home testing kits that they can give directly to parents/carers collecting a child who has developed symptoms at school, or staff who have developed symptoms at school, where they think providing one will significantly increase the likelihood of them getting tested. 	Parents, carers and staff will be asked to inform the school immediately of the results of a test.	Н	L

Further guidance is available on testing and tracing for coronavirus (COVID-19).

Staff are expected to talk to the Head Teacher about any changes in their circumstances or any individual worries they may have.

Head Teacher will continue to lead on supporting Teachers to mange their work/life balance. The mental health First Aiders will always be available to meet with colleagues who request it.

Staff are encouraged to flag up any concerns with the risk assessment or to suggest any changes to improve the document.

We will inform staff if a confirmed case of Coronavirus is found.

Changes will be made taking into account of health protection guidance

Lateral flow tests are available from the school office for all staff.
